



National Village **(NV)**
From Highway 280, Travel North on Grand National Parkway. Turn Right onto Robert Trent Jones Trail. National Village Subdivision will be on your left.

Autumn Ridge **(AR)**
From Shug Jordan Parkway, Travel North on N. Donahue Drive. Turn Left onto Highway 72 / Farmville Road. Travel 1.5 Miles, Autumn Ridge is on your left.

Village at Midtown **(YAN)**
From Auburn: Travel North on Opelika Road toward Opelika. Turn Right after Executive Square Shopping Center onto Yarbrough Drive. Village at Midtown will be on your right.

The Preserve **(P)**
From Shug Jordan Parkway, Travel North on N. Donahue Drive. Turn Left onto Highway 72 / Farmville Road. The Preserve will be on your right.

East Lake **(EL)**
From Moore's Mill Road, Turn Right onto Ogletree Road. East Lake Subdivision will be on your Left.

White Oaks **(WO)**
From E Glenn Avenue, Travel East toward Bent Creek Road. Turn right onto Bent Creek Rd. White Oaks will be on your right after crossing I-85.

Camden Ridge **(CR)**
From Shug Jordan Parkway, Travel North on N Donahue Drive. Turn Left onto Crescent Blvd into Camden Ridge Subdivision

From Shug Jordan Parkway, Travel North on N Donahue Drive. Yarbrough Farms will be on your left.

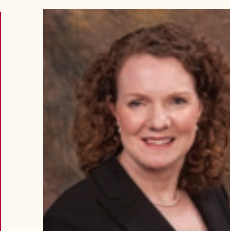

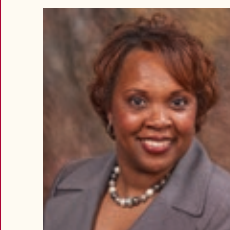

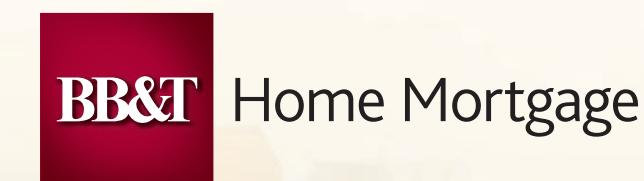
